Harbour Guest Boat Policy

Wexford Guest:

Welcome to Wexford Harbour. We take great pride in the condition of our Harbour. Strict compliance with Local, State, and Federal regulations is expected by all people using our Harbour. The following pages are taken from the Wexford Plantation Yachting Guide (the paragraph numbers are those used in the guide). The forms at the end must be completed by all visitors.

2.16 Guest Vessels:

2.16.1 Requirements.

Guest vessels must meet the standard requirements applied to vessels owned by Owners. For a guest vessel to enter or remain in Wexford Harbour, a Vessel Registration and Indemnification Release form (Section 7 hereof) must be completed and the Harbourmaster must be satisfied with the registration, insurance, and sewage discharge control.

2.16.2 Applicability

The requirements of this Section apply to all guest vessels whether the dock is behind private property, on a Wexford Yacht Club dock, or at a Wexford Plantation dock.

2.16.3 Responsibility

Sponsoring Owners are responsible for their guests, and guest vessels will be treated the same as member vessels.

2.16.4 Living Aboard Guest Vessels

Living aboard is limited to 14 days per quarter commencing from the date of entry.

2.16.5 Arrangements for the Different Harbour Areas:

2.16.5.a Privately Owned Docks

Owners may invite a visitor to use their private dock.

2.16.5.b Wexford Yacht Club Docks

Wexford Yacht Club Members may arrange for a visitor to use their assigned dock.

2.16.5.c Wexford Plantation Owned Docks

Guest vessels must:

- Either be a Yachting Club of America member or sponsored by an Owner.
- Obtain permission from the Harbourmaster.
- Limit their stay to 14 days.

Charges: Visiting vessels will be charged:

- Docking Fee: \$2.00 per foot overall length/per night
- Electricity: \$10.00 per night for 50 amp;
\$5:00 per night for 30 amp

If sponsored by an Owner, the docking fee is waived for the first night.

6. Wexford Harbour Indemnification and Release

6.1 Agreement between Wexford and Vessel Owner.

6.1.1 Wexford Harbour Yachting Guide Policies

The owner of the vessel identified below has read the policies and procedures described in the Wexford Harbour Yachting Guide and, by signing the Vessel Registration Form (Yachting Guide Section 7), is agreeing to accept the conditions and to abide by them.

6.1.2 Applicability

This agreement applies to vessels either owned by Owners or by guests, and applies to vessels moored in the marina area and at docks behind private homes.

6.1.3 Indemnification and Release

The vessel owner agrees to release and fully indemnify the Wexford from any and all claims which may be made against Wexford for any damage that may occur related to the presence of the vessel in Wexford's Harbour.

6.1.4 Insurance

The vessel owner confirms that there is current liability coverage on the vessel identified in the Vessel Registration form totaling at least Three Hundred Thousand (\$300,000) Dollars per occurrence and Fifty Thousand (\$50,000) Dollars property damage per occurrence through the insurance company(ies) and policy(ies) listed on Vessel Registration Form and that such insurance will be maintained so long the vessel is in Wexford Harbour.

6.1.5 Liability Acceptance

By being admitted to Wexford Harbour, the vessel owner accepts liability for any and all claims for damages resulting from the operation or the dockage of the vessel within Wexford Harbour including damage associated with an act of God, hurricane or other weather related incident.

6.1.6 Harbourmaster Authorization

The vessel owner authorizes the Harbourmaster and his employees to have access and right of entry to the vessel, whenever necessary, to respond to an emergency or accident.

6.1.7 Water Level

The vessel owner acknowledges that the Harbourmaster and his or her agents and/or employees, may at their sole discretion adjust the level of water within the Harbour commensurate with good planning in the face of an impending severe storm.

6.1.8 Release

The vessel owner agrees not to sue Wexford; Wexford Owners, Wexford Board of Directors, officers, or employees as a result of claims that may arise from the presence of the vessel within Wexford Harbour. In addition the vessel owner agrees to indemnify and hold harmless Wexford, the Harbourmaster, and his or her agents and/or employees, and to pay any attorney's fees that may arise from such claims except when damage occurs due to grossly negligent conduct or willful misconduct of the Harbourmaster or his or her agents and/or other Wexford employees.

9. Head Sealing Certificate

Water Quality

As a condition for Wexford's permit to operate this Harbour, South Carolina Department of Health & Environmental Control (DHEC) requires that we strictly monitor and maintain the quality of the water in the Harbour.

Head Sealing

After entering Wexford Harbour and providing the Harbour Center staff with the required information, you must securely seal off the discharge valves servicing your vessel's heads. When you have completed sealing the discharge valves, please return to Harbour Center and return this form completed and signed.

Certification

I certify that the discharge valves on the vessel named below have been sealed closed and will remain in the sealed closed position while the vessel remains in Wexford Harbour.
